

# SUMMER (FREE) FOOD PROGRAM



The East Irondequoit School Nutrition Program is participating in the U.S. Department of Agriculture's Summer Food Service Program, which provides [free meals to students during the summer](#). All kids in the community, 18 years and younger, can participate; you need not be an East Irondequoit resident.

**When:** Dates and times for Breakfast & Lunch vary by location. See reverse side for details.

**Where:**

- > Ivan Green School , Helendale Road School & Durand Eastman School will be an OPEN SITE with Walk-in's welcome.  
(Also housing the Irondequoit Summer Playground program)
- > Eastridge High School and East Irondequoit Middle School will be an OPEN SITE with Walk-in's welcome
- > Laurelton-Pardee will be closed.

**How much:** Free for Children 18 years old and younger.

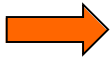
**What's on the menu:** Menus will be posted on the district's Website.



There are no income requirements and no registration is necessary, but meals must be eaten on site.



Parents and guardians can also purchase a meal. Breakfast is \$2.50 and Lunch is \$4.25.
