**School Board ACTION – NEW BUSINESS**

**Revised Board Policy 2090**

**WHEREAS**, the Board of Education of the East Irondequoit Central School District adopted Board Policy 2090 on August 4, 2020; and

**WHEREAS**, the Board thereafter revised Policy 2090 to be consistent with directives and recommendations of Governor Cuomo and the U.S. Centers For Disease Control & Prevention (“CDC”), so it is no longer necessary for individuals to wear face coverings while outside on School District property; and

**WHEREAS**, the Board thereafter revised Policy 2090 to make distinctions for the wearing of face coverings indoors on school property based on vaccination status against COVID-19; and

**WHEREAS**, the CDC has updated its guidance to recommend universal mask wearing indoors in K through 12 schools, regardless of vaccination status; and

**WHEREAS**, the Board seeks to modify Policy 2090 to be consistent with the aforementioned updated guidance;

**NOW, THEREFORE**, the Board of Education of the East Irondequoit Central School District resolves as follows:

1. The Board hereby resolves to waive its procedure for first reading and second reading of a policy prior to amending Board Policy 2090 given the urgency to amend its face covering policy to reflect CDC guidelines in advance of the reopening of schools for the 2021-2022 school year.
2. The Board hereby resolves to amend Board Policy 2090 to require all individuals to wear an appropriate face covering at all times while indoors on school property, regardless of vaccination status.
3. This resolution shall take effect immediately and the policy shall be posted on the District as soon as practicable following its passage.
